

## Shetland Classic Motor Show 2022

Saturday 4<sup>th</sup> June, 10am to 8pm & Sunday 5<sup>th</sup> June, 10am to 6pm. Clickimin Leisure Complex, Lerwick.

### Exhibitor Information Sheet, Information and Conditions to Entries

#### 1. General.

- 1.1 Access to the Complex will be from Noon on Friday the 3<sup>rd</sup> June, Car exhibits will be given a time slot to help reduce congestion and to allow the indoor exhibition halls displays to be in order. Please deliver your exhibits to the rear door of the Main Hall or Bowls Hall as advised. All exhibits must be clear of the Complex by 9pm on Sunday 5<sup>th</sup> June.
- 1.2 On arrival at the show please collect your show pack. Your exhibitor's badge should be worn at all times, this will allow free entry to the show.
- 1.3 For all vehicles displayed inside, the battery **must be disconnected and wiring safely secured** before being pushed into the Complex. Engines **must not** be run inside. If wet, vehicles will have to be dried off.
- 1.4 Oil drip trays are available for inside use. Please advise the Marshals of your requirements.
- 1.5 Any vehicle leaking fuel will not be allowed into the Complex.
- 1.6 No silicone based polishes are to be used inside the Complex as it will damage the floor surface. In some areas paper sheets will be used to prevent tyre marks.
- 1.7 Wood for under motorcycle stands will be used to protect the floor.
- 1.8 Marshals will be on duty and will do everything possible to ensure the security of exhibits, however, the show organisers cannot accept liability for any injury, damage or loss whatsoever.

#### 2. Insurance Cover and Movement of Vehicles within the Show Area.

- 2.1 It is the responsibility of all persons, whether they are the named entrant or not, to ensure that prior to driving any vehicle anywhere within the show area that they are legally covered against third party risks. Owners of vehicles have an additional responsibility to ensure that they do not 'Cause or permit' a contravention of this legal requirement.
- 2.2 No person shall drive a vehicle within the show area without being the holder of a Driving Licence covering the vehicle to be driven.
- 2.3 No person shall be carried anywhere within the show area on any vehicle which is not constructed or adapted to carry passengers, e.g. agricultural tractors.
- 2.4 During the event, no vehicle shall be driven within the show area except when its movement is permitted by a Marshal.

#### 3. Stationary Engines.

- 3.1 When in operation a Stationary Engine must be attended at all times to by either the entrant or a responsible person as delegated by the entrant.
- 3.2 Although the show organisers will provide barriers to prevent unauthorised entry by members of the public and sufficient space within the compound to ensure that a reasonable distance is available between engines, it is the responsibility of each entrant to ensure that no person can approach beyond a safe distance to the exhibit whether it is operating or not, from within the compound area.

3.3 The only persons permitted within the Stationary Engine Compound are the entrants or in the absence of any entrant, one responsible person acting on their behalf, the officially appointed Compound Marshal or other Official as directed.

**4. Acceptance of Information and Conditions.**

4.1 In submitting the accompanying entry form, it is accepted that all entrants have read, understood and are willing to abide by all the Information and Conditions.

**5. Disclaimer of Liability.**

5.1 The show organisers cannot accept any liability for any illness, accident, damage or injury to owners, drivers, spectators, ground, exhibits or any persons or property whatsoever.
